

LEGAL NOTICE

Sealed bids for the Riverside Local School District, Track Improvements project will be received by the Riverside Local School District – at the Board of Education Offices, located at 585 Riverside Drive, Painesville, Ohio 44077 until 1:00 PM, Prevailing Legal Time, Wednesday, April 10th, 2024 and will be read publicly and recorded immediately thereafter.

The proposed work consists of the furnishing of all labor, materials, and equipment necessary to provide resurfacing and improvements to the High School running track at the Riverside High School stadium.

Sealed bids shall be addressed to Gary Platko, Treasurer/CFO, 585 Riverside Drive, Painesville, Ohio 44077, and be clearly marked as “BID FOR: TRACK IMPROVEMENTS.” The responsibility for timely and appropriate bid submission rests solely with each bidder. Sealed bids submitted by mail must be certified or registered with return receipt requested. Sealed bids received after the above appointed date and time will not be accepted or opened.

A pre-bid meeting shall take place on April 2nd, 2024 at 2:00 pm at 585 Riverside Dr., Painesville, OH 44077, meet at the Board of Education Main Office.

Contract Documents may be purchased by Bidders only at their expense from ARC Planroom, 3666 Carnegie Avenue, Cleveland, Ohio 44115, telephone: 216-281-1234. Contractors will be required to purchase the complete set; no partial sets will be issued prior to the receipt of the bids and the award of the Contracts. Contract Documents may also be found at local online plan rooms.

All bids must be accompanied by a Bid Guaranty in the form of either a Bid Guaranty or Contract Bond for the full amount of the bid or a certified check, cashier’s check, or an irrevocable letter of credit in an amount equal to ten percent (10%) of the bid. All such bid guaranties and contract bonds must comply in all respects with applicable Ohio law for public school construction projects. Bid guaranties and contract bonds accompanying rejected bids will be returned upon award of the contract.

All bids shall be submitted on special blank forms furnished in the project manual, and shall be accompanied by a Bid Guaranty and Contract Bond conforming to Section 153.571 of the Ohio Revised Code.

The Riverside Local School District Board of Education reserves the right to accept or reject any or all bids in whole or in part, to waive any informalities or irregularities in the bids received, and to accept any bids which it deems favorable.

All submitted bids must comply in all respects with the requirements set forth in this Legal Notice, the Instructions to Bidders, Specifications and other bid documents. A bid will be considered nonresponsive if it fails to comply in all respects with this Legal Notice, the Instructions to Bidders, Specifications, and other bid documents and requirements. No Bidder may withdraw a bid for a period of sixty (60) days from the date of the opening of the sealed bids. The Riverside Local School District Board of Education reserves the right to reject any or all bids.
