BACKGROUND INVESTIGATION

As a potential candidate for employment in the Riverside Local School District, you are hereby notified that a satisfactory federal and Ohio criminal records check is a precondition for employment.

- Importuning
- Voyeurism

- Prostitution or procuring prostitution
- Compelling or promoting prostitution
- Pandering obscenity and/or child pornography
- Disseminating matter harmful to juveniles
- Pandering any sexually oriented materials involving or depicting minors
- Use of minor in nudity-oriented materials/performance
- Robbery or burglary or aggravated robbery or burglary

- Unlawful abortion
- Endangering children
- Contribution to unruliness or delinquency of child
- Domestic violence
- Carrying concealed weapon
- Having weapon while under disability
- Discharging firearm at or into school or residence
- Corrupting another with drugs
