2. Work Session

A. Work session for Superintendent Dr. Rateno to host a facilities visioning session with community members.

Dr. Rateno hosted an interactive meeting to get community thoughts and input on how they see the district. He reminded the community members of the vision of the district – "One community, pursuing greatness and getting better every day". He asked the attendees to think about that vision and put their thoughts on paper of what the ideal Riverside would look like. He then split them into six groups to write down what the group saw as strengths, weaknesses, opportunities and threats to each of six categories: LaMuth Middle School, Buckeye and Melridge Elementaries, Community Involvement, Equity and Fairness, Cooperation and Communication, and the Riverside Campus. Once that was done, each person was given three votes to tell which of those thoughts were the most important. He said it was clear that safety and security of the legacy buildings are most important to this group. He closed the meeting by saying that the results will be compiled after the same meeting at Melridge next week. He provided a QR code for attendees to scan to enter their name and email address to receive the results of both meetings, and to provide any other comments they may have.
